 - o Auditing school transportation budget, improving efficiency and equity
 - Improving process for individualized Education Plans
 - 3.5 billion city budget, approx 1/3 goes to schools
- Former Chair of Committee on Homelessness, Mental Health & Recovery
 - Homeless will now fall under housing committee
 - o Mental health and recovery will now fall under public health committee
 - Will still focus heavily on this issue advocating to end family homelessness and mental health services available for all ages.

UPDATE FROM THE MAYORS OFFICE

- Complaints made about Alex's Pizza not adhering to new 3:00 am hours, the abutters process, and cleanliness in front of store.
 - Faisa claims abutters all notified, no complaints raised at abutters meeting or ZBA hearing, no history of issues with Alex's, and no liquor license. Thus, approval was granted.
 - o 3:00am license means doors must close at that time, but patrons may stay until 3:30am.
 - Licensing board has sent inspectors twice found no violations (as of last week).
 - Did let them know they are on thing ice in regards to driver noise issues and double parking.
 - Please call 911 to register complaints. If they are caught in violation, they will be brought before the licensing board for a hearing.
- Traveler / Washington 2-way development have been working on curbing and signals. Will begin work in full force this Spring.
- No updates on Harrison Ave development, but monitoring progress with the Quinn and 1000 Washington.

- Street cleaning resumes on March 1. City looking to adjust the schedule so that even side of street is done on even weeks, and vice versa. Days would not change.
- Looked into alternate locations for the Blue Bikes by Peter's Park. ADA issues present on Shawmut side of park. Working with Parks Department to ideally place in previous Land Wave location. Bike may return to prior position, but only temporary.
- Boston experienced first case of Coronavirus. Public meting to be held on Friday, February 7 at the Josiah Quincy School at 6:30pm. Boston public health officials will attend.
- Member questions and comments:
 - o Rumor that Blackjack Pasta has applied for a late night license.
 - Waltham/Washington intersection was done with wrong pole color and bricks.
 - Faisa agreed. Noted that MassDOT was the contractor as federal funds were used. Led to some disconnect.
 - o 311 operators can't easily locate Peter's Park.
 - Whole Foods parking situation still a major issue.
